This report is a summary of the quality of the water we provide our customers. The analysis was made by using the data from the most recent U.S. Environmental Protection Agency (EPA) required tests and is presented here. We hope this information helps you become more knowledgeable about what's in your drinking water. Where do we get our drinking water? Our drinking water is obtained from a surface water source from the City of Mount Pleasant which comes from Lake Bob Sandlin. The TCEQ has completed a Source Water Assessment for all drinking water systems that own their sources. This report describes the susceptibility and types of constituents that may come into contact with the drinking water source based on human activities and natural conditions. The system from which we purchase our water received the assessment report. SPECIAL NOTICE - Required language for ALL community public water supplies:

ALL drinking water may contain contaminants

When drinking water meets federal standards there may not be any health-based benefits to purchasing bottled water or point of use devices. Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Secondary Constituents

Secondary constituents (such as calcium, sodium or iron) which are often found in drinking water can cause taste, color, and odor problems. The taste and odor constituents are called secondary constituents and are regulated by the state of Texas, not the EPA. These constituents are not causes for health concerns. Therefore, secondaries are not required to be reported in this document but they may greatly affect the appearance and taste of your water.

Water Sources

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals, and in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water before treatment include: microbes, inorganic contaminants, pesticides, herbicides, radioactive contaminants, and organic chemical contaminants.

Water Loss

In the water loss audit submitted to the Texas Water Development Board for the time period of Jan-Dec 2021, our system lost an estimated 32,237,682 gallons of water, including leaks, flushing lines, and fire department usage. Definitions:

Maximum Contaminant Level (MCL) – The highest contaminant level permissible in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG) – The level of a contaminant in drinking water below which there is no known or expected health risk. MCLGs allow for a margin of safety.

Maximum Residual Disinfectant Level (MRDL) – The highest level of disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for the control of microbial contaminants.

Maximum Residual Disinfectant Level Goal (MRDLG) – The Level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contamination.

Treatment Technique (TT) - A required process intended to reduce the level of a contaminant in drinking water.

Action Level (AL) - The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Abbreviations:

NTU – Nephelometric Turbidity Units; MFL – million fibers per liter (a measure of asbestos); pCi/L – picocuries per liter (a measure of radioactivity); ppm – parts per million or milligrams per liter (mg/L); ppb – parts per billion, or micrograms per liter (ug/L); ppt – parts per trillion, or nanograms per liter; ppq – parts per quadrillion, or picograms per liter.
